## MANDATORY THA/TKA PRO-PM

The hospital-level Total Hip Arthroplasty/Total Knee Arthroplasty (THA/TKA) Patient-Reported Outcome-Based Performance Measure (PRO-PM) **requires the collection of preoperative and postoperative patient-reported outcome (PRO) data** to (I) match to claims data and (II) calculate a risk-adjusted measure outcome. The data elements hospitals will need to collect and submit for each patient for the measure can be found below. CMS plans to implement the THA/TKA PRO-PM through a phased implementation, with two voluntary reporting periods in 2025 and 2026, followed by **mandatory public reporting** in 2027. Hospitals that fail to meet the reporting requirement (50%) receive a reduction in their APU in Fiscal Year (FY) 2028.


